AGED MINISTERS/WIDOWS ANNUAL OFFERING REFORMATION SUNDAY – OCTOBER 26, 2014

One of the primary ways the church demonstrated its love and respect for the retired ministers is through an annual day of emphasis. The Church of God has designated that as Reformation Sunday (the fourth Sunday in October). A special love offering is to be received for aged ministers and widows. This offering is to be mailed to the Secretary General with the October treasurer's report. Seventy-five percent (75%) of the amount raised is equally divided to all retired ministers who are 70 years of age and to ministers' widows, as a special Christmas offering. The remaining 25% is placed in a designated fund from which emergency needs of retired ministers and widows can be assisted.

We are asking that each pastor and local congregation help us reach our goal of \$3,000.00 by receiving a love offering for these very special people on Sunday, October 26. This is only a small way we can share with them our love and appreciation.

This special Sunday is also a time for recognition of and appreciation for retired ministers and widows. In many churches, pastors are inviting a retired minister to preach on this Sunday.

WHY PAY THIS MORTGAGE OFF?

The New River Debt Reduction Plan does not add any extra cost to the local congregation and is a fair way for each congregation to participate in the elimination of the New River Properties Mortgage and save thousands of dollars in interest.

The 2 1/2 % Home Missions is the fund from which the mortgage is paid. With the reduction of funds, the 2 1/2 % fund is being eliminated, leaving no fund to pay the mortgage.

In an effort to eliminate the mortgage on the property housing the New River Ranch Children's Home Ministries and the New River Ministry Center (Campground), the ministers passed in a special called ministers meeting that 1½ % reduction of funds to the State Office beginning September 1, 2012 and the 2% beginning September 1, 2013 continue to be forwarded by the local church to the State Office designated as New River Property Debt Reduction, NRDR.

It is understood that this is a volunteer measure to be considered by the local church and that our church government operates as a democracy where we all support the decision of the body.
