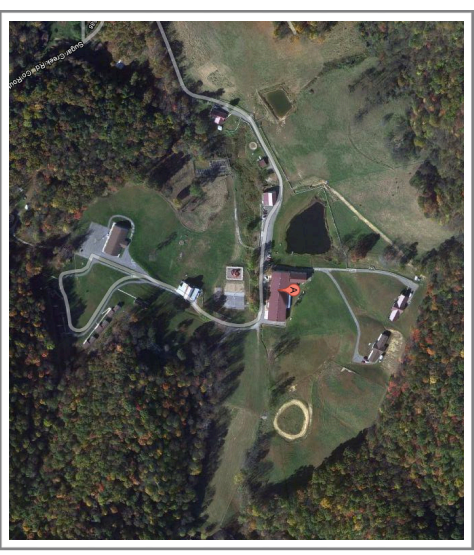

Basic Directions

- I-77 South into West Virginia. Take exit 48 (North Beckley-Summersville, Rt. 19).
- Drive through .25 cent toll booth. Drive on Rt. 19 North approximately 15 miles. Turn left at the Fayetteville Red Light-Rt. 16 (Tudor's Biscuit World is on the right...Also, there will be a large pedestrian bridge that crosses over Route 19... Turn left just before the pedestrian bridge).
- Drive approximately 4 miles to Fayette County Park Road-Turn left (There will be a small New River Ranch sign on the right side of the road).
- Travel 1/2 mile and turn left onto 1 lane paved road. There will be another New River Ranch sign on the right side of the road. This 1 lane road is open to 2-way traffic... BE CAREFUL!
- Drive about 1/2 mile and turn left to the Ranch (There will be another New River Ranch sign on the right side of the road). **Directions via google from Charleston, WV**

CAMP INFORMATION

What You Are Responsible To Bring

- Bedding.. Twin sheets, sleeping bag, blanket, pillow; towels, washcloths and toiletries; sports clothes for activities such as a swimsuit and cover-up; a light jacket, SUNSCREEN, BUG REPELLENT, a hat and any other personal items needed. You might want to bring a flashlight but the camp is well lit at night. Remember, this is a Christian camp and we strive to maintain an environment that glorifies Christ. We provide three great meals every day but you will probably want to snack at the concession stand or grab an energy drink, Speciality Soda or Cappuccino at the cafe. You might even want to buy something at the camp store.

What Not to Bring

- Do not bring...short skirts and short shorts; revealing tops; weapons of any kind; fireworks; tobacco or nicotine products; alcoholic beverages; drugs; non-prescription medication; expensive cameras; expensive jewelry. West Virginia Church of God Youth Camp is not responsible for any items lost or stolen at Youth Camp.

Camp Credit

- We don't use cash at Youth Camp. Cash money is exchanged for "Camp Credit Cards." These cards are carried by the camper. Each time they make a purchase, that amount is taken off the card. In this way no "real" money is lost or stolen. Campers should write their name on each camp credit card so that it can be returned if found. At the end of camp, if any camper has left over camp credit cards, an amount equal to their remaining credit will be returned to them. During Kids camp, counselors hold campers camp credit cards so that they can keep track of the card & the campers spending. The young campers tend to spend their money extremely quick so counselors are encouraged to keep an eye on them.

Camp Safety and Administration

- West Virginia Youth Camp is a wonderful place for kids to get away from life's pressures and share time with friends while having fun in a Christian environment. Every attempt is made to provide the utmost security and safety for your child. Around the clock emergency first aid medical care is provided. The entire camp staff is carefully screened to make sure that they are suitable to work with campers. Training sessions for all our staff is mandatory. The camp board of directors (composed of the Camp Director and the State YMD Board) have been empowered to make decisions in the best interest of the West Virginia Youth Camp and those attending. All Campers and their parents/guardians recognize the board of directors as the authority in any altercation or situation.

Health & Medical Info You Need To Know

- Medical Insurance is provided as a secondary coverage to the primary insurance of the camper's family. Our policy insures that you have no "out of pocket" cost for any medical treatment rendered to your child while in our care.
- All medications will be administered by a nurse. Prescriptions should be clearly labeled. Please send only the exact amount for the time at camp. Medications should be checked in with the staff nurse during registration.
- Food allergies and/or caffeine restrictions or intolerances should be listed on the camper application under medical information.
- **Head Lice Policy**
- We have a NO TOLERANCE POLICY REGARDING HEAD LICE AND NITS. Each camper and staff member are checked by our nurse and staff during the registration process. If infected, the child will be returned to the care and responsibility of the person who brought them. They will not be permitted to join the camp. In such cases, all registration money will be returned in full (less the \$25 deposit) at this time.

Check-in/Check Out Times

- Teen Camp June 15-19 **Check-in** will begin at 1PM and end at 3PM on the opening day of camp.
- Middle Camp June 22-26 **Check-in** will begin at 1PM and end at 3PM on the opening day of camp.
- Kids Camp June 29-July 2 **Check in** will begin at 1pm and end at 3pm on the opening day of camp

- **Check-out** will be at 10:30 AM on the closing day of respective camp. Camper must be picked up by 10:30 AM!
